ENROLLMENT AGREEMENT 2007-2008

I understand that I am registering my below listed child for the 2007-2008 school year.

- _____ Young Two's – Tuesday/Thursday in the amount of \$185.00/month
_____ Two's – Tuesday/Thursday in the amount of \$165.00/month
_____ Two's-Wednesday/Thursday/Friday in the amount \$200.00/month
_____ Three's – Monday/Wednesday/Friday in the amount of \$200.00/month
_____ Three's – Monday through Friday in the amount of \$300.00/month
_____ Four's – Monday through Friday in the amount of \$300.00/month

I agree to pay \$75.00 for supplies and materials and \$15.00 program fees to be paid no later than the first day of the school year.

I understand that a one time \$100.00 registration fee is required at the time of registration. I understand that the registration fee is non-refundable and does not apply to any outstanding tuition or fee. I understand that to guarantee a placement in the coming school year I must pay a non refundable deposit in the amount of three months tuition. A payment of the registration fee only will hold a place for my child on the waiting list.

_____ I wish to guarantee my child's placement in the OLA Preschool and have enclosed a check for three months tuition and registration in the total amount of \$_____.

_____ I wish to have my child placed on the waiting list for the above indicated class and enclose a check in the amount of \$100.00 only.

I understand that OLA Preschool is open according to the official school calendar of Our Lady of the Assumption School, and is closed during vacations (Thanksgiving, Christmas, Spring Break, Holy Thursday, Good Friday), legal holidays (Labor Day, Columbus Day, Martin Luther King, Presidents Day and Memorial Day) and inclement weather days. OLA Preschool *may be closed at any time at the discretion of the Director*. I understand I will be assessed late charges in the amount of \$5 for the first minute and \$1 for each minute thereafter until my child is signed out of the program.

I understand that I am responsible for payment of program fees which are due no later than 15 days after the first day of each month. Payments received after the due date will accrue late charges in the amount of \$25.00 per billing period. Should I decide to withdraw my child from the program, I agree to give one month's notice in writing prior to the discontinuation of service and bring **all outstanding balances current**.

I understand that I am required to complete and return this and all other required documents to OLA Preschool before my child attends the program. The Archdiocese of Atlanta prohibits any child from admission into the OLA Preschool without all current, signed documentation on file at the office. Children attending the OLA Preschool without proper immunization records will be removed from the program until such certificate is on file in the school office.

I AGREE TO PAY ALL FEES FOR MY CHILD'S ENROLLMENT IN THE OLA PRESCHOOL PROGRAM. I UNDERSTAND THAT MY CHILD'S CONTINUED PARTICIPATION IN THE PROGRAM IS DEPENDENT UPON ALL FEES BEING PAID IN A TIMELY MANNER.
